The bids are invited into two parts, i.e., **Qualifying/Technical Bid and Financial Bid.** The Qualifying/Technical Bid consists of all technical details along with commercial terms and conditions as per the proforma at **Annexure–I.** The Financial Bid for the items mentioned in proforma at **Annexure–II & III.**
- 4. ### C. <u>EARNEST MONEY DEPOSIT (EMD) / PERFORMANCE SECURITY :-</u>

- 1. Earnest Money Deposit (EMD) of Rs. 1,00,000/— (Rupees One Lakh only) in the form of a crossed Demand Draft from a commercial bank in favour of "National School of Drama, New Delhi" shall be kept in the envelope containing the Technical bid. It is essential that the participating firm have to submit the EMD/Performance Security for consideration of their tender. No exemption is applicable on EMD/Performance Security, no representation in this regard will be considered and NSD decision will be final.
- 2. No interest shall be paid by NSD on the EMD for the above said period.
- 3. The EMD deposited is liable to be forfeited, if the tenderer withdraws or amends impairs or derogates from the tender in any respect, within the period of validity of his offer.
- 4. The EMD of successful bidder will be retained as Performance Security till completion of work.

### D. SCOPE OF WORK:-

The selected firm/agency shall be responsible to :-

- 2. The transporters should have at least a fleet of 10 Vehicles.
- 3. The tenderer will be required to provide cars & buses to the NSD on prior notice. The tenderer will also be required to provide cars & buses at short notice, i.e., even at the notice of half an hour over telephone.
- 4. The transport shall appoint experience and skillful drivers and they shall have valid driving license and they should be their employees. Obtaining the necessary permission/approval of the concerned State police/appropriate authorities shall be the responsibility of transporter.
- 5. In case of breakdown of any vehicle, the firm/contractor shall be able to provide services of additional vehicle.
- 6. The transporter shall ensure that the vehicles provided are in good condition, road worthy with proper/comfortable seats to withstand the stains of long journey.
- 7. The transporter will be responsible for any mis-happening while on journey in their vehicles.
- 8. The services provided by bidder shall be to the entire satisfaction of NSD.

### E. EVALUATION OF TENDER

- 1. The tender will be evaluated by a committee.
- 2. The Technical Bid will be opened in the first instance in the presence of the tenderers or their representatives. Only one authorized representative per tenderer, will be permitted to be present at the time of opening of tender.
- 3. If the Tenderer qualifies in the technical bid, then only its financial bid shall be opened. The financial bids shall be opened by a Committee constituted by the NSD.

4. NSD reserves the right to select the tenderer on the basis of best possible bids received. The decision of the Tender Evaluation Committee arrived at as above shall be final and representation of any kind shall not be entertained on the above. Any attempt by any bidder to bring pressure of any kind may disqualify the tenderer for the present tender and the tenderer may be liable to be debarred from bidding for NSD tenders in future for a period of three year.

### F. GENERAL CONDITIONS OF THE CONTRACT:-

- 1. The Director, National School of Drama reserves the right to accept or reject any & all tender(s) without assigning any reason(s) thereof. No bidder shall have any cause of action or claim against the NSD for rejection of his tender.
- 2. The Director, National School of Drama reserves the right to select the bidder on the basis of rates quoted, past experience and reasonability of charges for execution of this work. The decision of the Tender Evaluation Committee arrived at as above shall be final and representation of any kind shall not be entertained on the above. Any attempt by any bidder to bring pressure of any kind may disqualify the bidder for the present tender and the bidder may be liable to be debarred from bidding for tenders in future for a period of three years.
- 3. National School of Drama does not bind itself to accept the lowest or any other tender and reserves the right to reject any or all the tenders. Tenders in which any of the prescribed conditions are not fulfilled, shall be summarily rejected.
- 4. NSD will not be responsible for any misinterpretation or wrong assumption by the bidder, while responding to this tender.

In case of any dispute with regard to the interpretation of any clause(s) of this agreement, the same shall be referred to the sole arbitrator appointed under the provision of Indian arbitration and conciliation Act 1996 by NSD (Ist Party) at the cost of both the parties in equal measure, whose decision will be final and binding on both parties. All the disputes arising between the parties shall be tried within the Delhi jurisdiction.
