## **TENDER NOTICE FOR HIRING OF TENT MATERIAL**

National School of Drama invites sealed tenders from eligible and reputed agencies for **providing Tent material on hiring basis during International Theatre Festival 24<sup>th</sup> Bharat Rang Mahotsav (BRM) to be held from 28<sup>th</sup> January to 16<sup>th</sup> February, 2025 in New Delhi.** Agencies shall have relevant experience of having provided similar services to Government organizations/PSUs.

The bids are invited in two parts, i.e. 'Technical Bid' and 'Financial Bid'. Technical Bid should contain all technical details, as per the proforma at 'Annexure - I'. The Financial Bid should indicate item-wise prices, as per the proforma at 'Annexure - II'.

Interested and experienced firms fulfilling necessary eligible criteria may submit their bids as per the terms & conditions mentioned below:-

### **A. PRE-QUALIFICATIONS FOR TENDERERS FOR 'TECHNICAL BID':-**

**Bidders are required to submit the following information/documents in 'Annexure – I':-**

1. Demand Draft for Earnest Money Deposit / Performance Security (document to be enclosed).
2. PAN No. (document to be enclosed).
3. Goods & Service Tax (GST) Registration No. (document to be enclosed).
4. Registration certificate of agency (documents to be enclosed).
5. Certificate from Chartered Accountant with clear name, address, signature & stamp certifying the turnover of the firm for the financial year 2022-23 & 2023-2024 and should be not less than rupees 75 Lakh in each year (document to be enclosed).
6. Undertaking certificate as per 'Annexure – III' on Rs. 10/- non-judicial stamp paper duly signed, stamped & notarized to be attached. Without Undertaking tender will be outrightly rejected. (document to be enclosed).
7. The bidders should submit the Work Order / Satisfactory / Completion certificate of at least 2 nos. projects for providing Tent Material services in Government organizations / PSU / autonomous bodies at Delhi, will be applicable only (documents to be enclosed). The work must be carried out in last five years only.

8. The Work order / Satisfactory / Completion certificate (clearly indicating the date of issue) will only be considered and should be issued by the authorized signature of issuing authority clearly, Name of the services provided, Name of the issuing Govt. organization etc.
9. Rate should be inclusive of all charges which are applicable i.e. Transportation & Labour etc. GST as applicable will be paid extra. TDS will be deducted from the bills as applicable. Noting extra will be paid.
10. Tender will be awarded to the bidder who will quote lowest rates for maximum number of items.
11. The services provided by bidder shall be to the entire satisfaction of NSD and decision of NSD will be final.

The Technical Bid and Financial bid should be sealed by the bidder in separate covers duly superscribed “**Tender for hiring of Tent Material for 24<sup>th</sup> BRM-2025 - Technical Bid (Annexure - I)**” and “**Tender for hiring of Tent Material for 24<sup>th</sup> BRM-2025 - Financial Bid (Annexure - II)**” respectively and both these sealed covers have to be put in a bigger cover which should also be sealed and duly superscribed “**TENDER FOR HIRING OF TENT MATERIAL FOR 24<sup>th</sup> BRM-2025**”. The tender in the prescribed format should be addressed to **The Registrar, National School of Drama, Bahawalpur House, 1, Bhagwandas Road, New Delhi-110001** to be dropped into the tender box kept at the Reception of NSD on or before **22.01.2025 till 1500 hours**.

**C. EARNEST MONEY DEPOSIT (EMD) / PERFORMANCE SECURITY :-**

1. Earnest Money Deposit (EMD) / Performance Security of **Rs. 1,00,000/- (Rupees One Lakh only)** in the form of a crossed Demand Draft from a commercial bank in favour of “**National School of Drama, New Delhi**” shall be kept in the envelope containing the Technical bid. It is essential that the participating firm have to submit the EMD/Performance Security for consideration of their tender. No exemption is applicable on EMD/Performance Security, no representation in this regard will be considered and NSD decision will be final.

2. No interest shall be paid by NSD on the EMD / Performance Security for the above said period.
3. The EMD / Performance Security deposited is liable to be forfeited, if the tenderer withdraws or amends impairs or derogates from the tender in any respect, within the period of validity of his offer.
4. The EMD / Performance Security of successful bidder will be retained as Performance Security till completion of work.
5. EMD / Performance Security of all un-successful bidders will be returned within a reasonable time period after a decision is taken on the tender enquiry.

**D. SCOPE OF WORK:-**

1. NSD can hire tent material as per their requirement for 24<sup>th</sup> BRM w.e.f. 28<sup>th</sup> January to 16<sup>th</sup> February 2025 (20 days). If number of days increase or decrease, the payment for extra days will be made on pro-rata basis. The rates of the items will remain valid for one year from the date of placing of the order.
2. The best quality of all the tent materials should be provided by the bidder. The services provided by bidder shall be to the entire satisfaction of NSD and decision of NSD will be final.

**E. EVALUATION OF TENDER**

1. The tender will be evaluated by a committee.
2. This is to bid system and the Technical Bid will be opened firstly in the presence of the tenderers or their representatives. Only one authorized representative per tenderer, will be permitted to be present at the time of opening of tender.
3. The Financial bids of the tenderers who are technically at par, will be opened in presence of members of the committee duly constituted by the Director, NSD.
4. NSD reserves the right to select the tenderer on the basis of best possible bids received. The decision of the Tender Evaluation Committee arrived at as above shall be final and representation of any kind shall not be entertained on the above. Any attempt by any bidder to bring pressure of any kind may disqualify the tenderer for the present tender and the tenderer may be liable to be debarred from bidding for NSD tenders in future.

**F. GENERAL CONDITIONS OF THE CONTRACT:-**

1. The Director, National School of Drama reserves the right to accept or reject any & all tender(s) without assigning any reason(s) thereof. No bidder shall have any cause of action or claim against the NSD for rejection of his tender.
2. The Director, National School of Drama reserves the right to select the bidder on the basis of rates quoted, past experience and reasonability of service charges for execution of this work. The decision of the Tender Evaluation Committee arrived at as above shall be final and representation of any kind shall not be entertained on the above. Any attempt by any bidder to bring pressure of any kind may disqualify the bidder for the present tender and the bidder may be liable to be debarred from bidding for tenders in future.
3. National School of Drama does not bind itself to accept the lowest or any other tender and reserves the right to reject any or all the tenders. Tenders in which any of the prescribed conditions are not fulfilled, shall be summarily rejected.
4. The bidder should be satisfied in all respect, before submitting the tender. NSD will not be responsible for any misinterpretation or wrong assumption by the bidder, while responding to this tender.
5. If the bidder qualifies in the technical bid, then only its financial bid shall be opened.
6. All the tender documents should be stamped & signed as a token of acceptance of all terms & conditions of the tender documents to avoid rejection of tender. Also, the photocopies of the original documents attached along with the tender to fulfill the eligibility condition should be paginated, self-certified and stamped by the duly authorized person of the bidder for this purpose.
7. The bidder will have to produce the originals of the photocopies attached for the purpose of verification, whenever required.
8. All documents enclosed must be in the name of the firm, participating for the tender. The bidder will have to produce the originals of the photocopies enclosed for the purposed of verification whenever required.
9. In case of non-fulfil of all the above conditions/non-submission of all the specific/complete documents asked, the tender will liable to outright rejection and decision of NSD will be final.
10. In case the bidder is found in breach of any condition(s) of tender, at any stage, may invite legal action as per rules/laws and EMD/Performance Security shall likely to be forfeited, besides being liable to be debarred.

11. Bidder shall not sub-let or sub-contract any part of this contract/job without the expressed written consent of the NSD. The bidder shall be responsible for the conduct/integrity of his personnel and will also be responsible for any act of omission and commission on their part. He will vouch for their character & integrity.
12. All the statutory requirement to be complied as per government rules & regulations.
13. Bids and all accompanying documents shall be in English, in case any document is in other language, it shall be accompanied with its English translation. The English version shall prevail in matters of interpretation and decision of NSD will be final in this regard.
14. Conditional tender will not be accepted at any cost or in any circumstances.

**G. TERMINATION OF CONTRACT:-**

In the event of services rendered being found unsatisfactory, the contract is liable to be terminated immediately and EMD/Performance Security deposit will be forfeited without giving any notice. The decision of the Director, NSD in this regard will be final.

**H. DISPUTE RESOLUTION:-**

In case of any dispute with regard to the interpretation of any clause(s) of this agreement, the same shall be referred to the sole arbitrator appointed under the provision of Indian arbitration and conciliation Act 1996 by NSD (Ist Party) at the cost of both the parties in equal measure, whose decision will be final and binding on both parties. All the disputes arising between the parties shall be tried within the Delhi jurisdiction.
