

All the pensioners/family pensioners are hereby informed that they may avail the medical facility in the aforesaid hospital at CGHS rates on Cash basis for OPD/IPD treatment. Reimbursement of expenditure on IPD treatment is permissible for availing treatment by the retired employees and their dependent family members from all the Government, Private Hospitals recognised by CGHS and hospitals empanelled by NSD. However, reimbursement of IPD medical claims will be allowed to the pensioners at 50% of the rates notified by CGHS for retired employees and their dependent family members. Extra amount charged, if any, over and above the CGHS rates shall be borne by the employee concerned.

The medical facility to the employees in the above hospitals shall remain valid till the hospitals are on CGHS/NSD panel.

This issues with the approval of the competent authority.
